³The “crematories” on Davids Island were used for trash disposal. The terms “incinerator” and “crematory” were roughly synonymous in the late nineteenth century, when furnaces for the disposal of both trash and human remains were first introduced. By roughly the 1930s, the terms had become differentiated, with “crematory” coming to mean a furnace for burning human bodies and “incinerator” referring to a furnace or other burner device for trash disposal.

⁴Both terms given here, Sighting Station and Battery Control Building, are functional descriptions supplied by architectural historians who studied the remnants of Fort Slocum in the 1980s and 2000s. Research to date has yielded few records from the 1950s and early 1960s for Nike missile battery NY-15, whose Integrated Fire Control (IFC) area was situated on Davids Island at Fort Slocum, so a historically documented name for this building is lacking. Period sources and later historical accounts of other Nike missile batteries and the general system sometimes use the term “battery control building” to identify structures similar to Building 124. However these sources also refer to such buildings as “corridor buildings” or “electronics shops,” because the masonry structures were the connectors between two key operations trailers of the IFC Area, the Battery Control and Radar Control vans.
